
East Bay Regional Parks: Our Local Treasures in Word and Image

Enjoy a multimedia presentation and be inspired to enjoy the beauty around us!





LUMC COUNCIL MINUTES April 17,2007

The Council Meeting was called to order at 7:30 by Chairperson Pat Hershey. Robyn Roberts, Tom Henderson, Ginny Leavitt, Pastor Lori Sawdon, David White, Joe Darrell, Ginny Cowden, Doug Cowden, Dean Coons and Mary Hobson attended. Joys and Concerns were shared. Pastor Lori brought up the sadness at Virginia Tech this week. In the Bible, we can read about when David's son Absalom was killed in battle. David grieved, as did so many parents this week in Virginia. In Psalms the prophets tell us after deep grief, hope will finally come. God is still there and he will continue to act. God's love reigns forever.

COMMITTEE REPORTS

Church Life - this will be continued next meeting.

<u>Staff Parish</u> – Ginny Cowden reported that Staff Parish had discussed and brought before the Finance Committee a recommendation for church contributions under the United Methodist Personal Investment Plan (UMPIP). Participation by the church is discretionary under this plan, so Staff Parish recommends that if there are funds available at the end of the year, the church contribute to the plan on behalf of all eligible employees. If funds are not available to make a contribution to all eligible employees, but some funds are available, Staff Parish recommends that LUMC make a contribution to the plan on behalf of the eligible employees who themselves contribute to the plan up to a maximum of 2% of the eligible employee's salaries. Discussion followed. Mary Hobson seconded the recommendation. All agreed except one.

•Ginny then brought up the changes to the Clergy Pension Plan made by the General Conference, which were effective on January 1, 2007. The effect of these changes is that our pastor loses \$60 per month in pension contributions. Staff Parish recommended that the pastor receive an extra compensation of \$60/month in pension contributions, retroactive to January 1, 2007. The pastor may choose to contribute this amount to the

plan, which would keep her whole. Ginny Leavitt seconded the recommendation. Motion carried. This recommendation will be considered for approval at a Charge Conference led by Jim Lockwood-Stewart on May 15, 2007.

•Pastor will be attending a conference on April 25-27, and will be at the LUMC Retreat on April 29th. Pam Abbey will be the preacher on that Sunday.

<u>Finance Committee</u> - Ginny Leavitt said that the 2005 Audit was finally "wrapped up", and that it showed our books to be in good order. The 2006 Audit was completed at the end of March, and the auditor plans to get the report to us in June. Jim Lockwood-Stewart congratulated us for giving 100% of our apportionments due.

<u>Treasurer's Report</u> - David White passed around copies of the February and March 2007 Treasurer's Report. Feb. and March were good months financially, although pledged income was less than anticipated. He also mentioned that the cost of the Audit increases each year.

<u>Program Council</u> - Pastor Lori said that the surveys from the congregation showed most interest in the following areas: an International lunch, an Advent event, an art and talent show, a film festival, Halloween party and family fun nights. She will try to get some folks in the congregation to lead some of these events.

<u>Trustees</u> - Joe Darrell reported that the Trustees met on April 9th. The cedar trees in the front of the church have been trimmed. Dry wall and plaster repair has been done in the kitchen and Maggie Mae lounge. There is new furniture in the Maggie Mae lounge. There is a new structure around the meter area outside. This was done by Vic Smith and Peter Vanderliet. Greg Horner worked on the parsonage garage. Joe said we are on track for the budget. There was a request to the Trustees for funding for a Landscape Plan. The Trustees approved this and the architect is to develop a master plan. Mason Walters will review the scope of work prepared by the architect. Tom Henderson asked if all the Boy Scouts were recognized for their work. They have been recognized.

Old Business - none

Tom moved that we adjourn the meeting. David seconded. Next meeting will be on May 15th, 2007.
