LUMC Church Council Minutes June 15, 2010

Members present: Chairperson Tom Henderson, Pastor Lori Sawdon, Doug Cowden, Ginny Cowden, Ginny Leavitt, Dean Coons, Lynn Sabatini, Bob Lewis, Carol Slatten and Secretary Kurt Teichmann.

The meeting began with sharing of Joys and Concerns. Chairperson Henderson officially opened the formal meeting at 7:37. The April 10, 2010 Church Council minutes were presented. Motion to approve by Carol Slatten, Seconded by Doug Cowden. Approved unanimously.

Finance: Chairperson Bob Lewis reported that through May 30, pledged income was \$9,500 under budget while non-pledged income was about \$6,300 above expectations. Plate offerings were \$400 under expectations while Special Offerings were about \$900 above budget. Use of church facilities was \$900 below budget. Parking lot use is running about \$1,000 above expectations. Total Income was about \$2,400 below

budget. Administrative office Maintenance and Building Maintenance expenses are running about \$3,100 below budget. Programs were \$400 under budget. Our Pastor's expenses are running \$500 below expectations. Staff and Staff expenses are running about \$9,100 below budget of which about \$4,300 is because a Youth Director has not been hired. Total expenses are running about \$12,600 below budget. Overall, Net Income is currently about \$10,200 over budget. The process of hiring a new Youth Ministry Director may not occur until Fall but this will affect expenses the remainder of the year. There were no significant Balance Sheet changes to report.

Trustees: The Courtyard Committee has begun interviewing landscape architects for the major courtyard project. Chairperson Henderson distributed an email from Trustee Pat Porter which reported that retaining wall repairs (from the parking lot to the courtyard) are to be done in June, the parking lot was restriped in May and hot water was installed in the office lavatory. Boy Scouts helped with the parking lot restriping. The Trustees are in the process of buying a new sound system for the Sanctuary. The Trustees toured the Education Building and Fellowship Hall and noted many items needing attention. The length of the list (2+ pages) will require prioritizing. The Trustees plan to walk through the Sanctuary at their next meeting.

Staff Parish: The Committee will step up its advertising for the Youth Director position. **Program Council:** Ginny Leavitt reported that there were 21 for a Sunday evening dinner at El Jarros. There will be hamburgers plus a pot luck for Fathers' Day on June 20. For the June 27 service, members are invited to wear the clothes they will wear the rest of the day. Jazz in July is scheduled for the last Sunday of that month. Sign ups for the A's game including fireworks have been going well.

Endowment: Committee Chairperson Doug Cowden reported that Endowment had approved an outreach grant of \$250 for the church's volunteer mission to Costa Rica through VIM. Inreach grants of \$400 for the Youth Ministry for the purchase of contemporary language Bibles and \$255 to the Worship Commission for a new Nativity Scene for the church and \$1,132 to the Trustees for new stand-alone campus maps. Motion to approve these grants made by Kurt Teichmann, seconded by Ginny Cowden, and approved unanimously. Also, the Endowment Committee requested approval of a \$250 grant from the Inreach Fund for scholarships for the church's annual retreat and a \$250 grant for the Retreat Fund for the annual retreat expenses. Motion to approve these grants made by Doug Cowden and seconded by Ginny Leavitt. Approved unanimously. Doug Cowden also reported that the Investment Policy was in its fourth draft so should be finalized soon.

Old Business: Ginny Leavitt said that the Smith Barney account was no longer needed and would be closed.

Chairperson Henderson noted that so many Church members contributed their time to the church so it would be good to recognize them. Pastor Lori noted that a high percentage of worship attendees also participate in other ministries of the church. She will prepare a Tower Notes article to report on this.

New Business: Pastor Lori, Tom Henderson, Jack Cotteral and Ginny Leavitt attended the most recent Lafayette City Council meeting. It was reported at that meeting that Lafayette had agreed to purchase the property on Moraga Road adjacent our play area. The price is \$2.3 million. The City is planning a parking lot for up to 72 vehicles. The ramifications of this were discussed. These four members have been

part of an ad-hoc Property Committee that includes Mark VandenBerghe, Joe Darrell, and Pat Hershey. Motion to make this a permanent committee with the addition of a member of Trustees was made by Doug Cowden, Seconded by Carol Slatten, and approved unanimously.

The upcoming Annual Conference is to vote on whether each church in the Conference must pay for its minister's pension directly rather than through apportionments. The drawback of paying from apportionments is that it is a voluntary-best-efforts basis so not all churches have been paying them. Since LUMC has been regularly paying its apportionments, paying just its own minister's pension would save LUMC over \$6,000. Pastor Lori asked for feedback on whether LUMC would want to donate that savings to help pay for other churches' pensions. This was discussed at length with the consensus being that we should not.

Communications: We received a certificate from the Conference recognizing our paying 100% of apportionments and askings for 2009.

Pastor Lori distributed copies of the book <u>SiMPLE CHURCH</u> to the Committee members. It was agreed that all members would try to read the first 82 pages by the next meeting.

The next Church Council meeting will be combined with the Finance Committee meeting. It is scheduled for 7 p.m. on July 20th. Motion to adjourn by Doug Cowden and seconded by Dean Coons. Approve unanimously at 9:15 p.m.
